**Functions of the Department Development Committee**

Subject to the existing provisions in the administrative guidelines of the department and the rules laid down by the institution shall meet twice in a year and has power to:

- Review the existing curriculum and suggest improvements to enhance its relevance, effectiveness, and alignment with industry standards. This could involve suggesting new courses, revising course content, and updating teaching methodologies.
- Stay updated on current industry trends and skill requirements. Identify potential gaps between the department's curriculum and the industry's needs. Suggest industry expert lecture/guest lectures.
- Based on industry trends and student needs, the DDC can recommend new specializations to be added to the department's curriculum. Suggest add-on/value added courses.
- Suggest innovative teaching methods that promote student engagement, critical thinking, and deeper understanding of concepts.
- Advise strategies to improve student placement, Higher education, Entrepreneurship opportunities.

- Recommend areas of research focus for the department, considering emerging trends and faculty expertise. Advise faculty to identifying potential funding sources for research projects.
- Encourage collaboration between faculty members on research projects. Promote innovation and entrepreneurship within the department.
- Advise on the development and maintenance of departmental infrastructure and facilities like laboratories, libraries, and IT resources.

**Term:** The Department Development Committee (DDC) shall be reconstituted every three years.

**Meetings:** Meetings of the Department Development Committee (DDC) shall be held at least twice a year.


