Management representative Dr. V. Madhusudhan Rao, Rector, and Dr. B. Arundhati, Principal and Chairman of the Academic Council Meeting (ACM), cordially welcomed all the members to the Academic Council Meeting.

1. Dr. B. Arundhati, Chairman, introduced all the internal members to the Council. He highlighted various honors and activities of the institution.

2. Prof. V. Madhusudhan Rao, the Rector, introduced the external members to the Council. He instructed the Dean Academics to initiate the presentation of Academic Regulations to the Council.
3. Prof. A. Naga Jyothi, Dean Academics, presented the highlights of VR20 and VR22 curriculum of UG and PG programs.
4. The Dean Academics presented the following points to the members of the Academic Council.

Item no 1: VR 20 & VR 22 Curriculum- Highlights

Discussion:

- The Dean Academics presented the highlights and syllabi comparison of VR 20 with that of VR 22 curricula to the members. She emphasized Skill-oriented courses, Special courses (audit courses), Summer internships, Industrial or Research internships, and Semester-long internships introduced in the curriculum.
- Distribution and weightage of marks for Theory courses, Laboratory courses, Projects, Internships, Skill-oriented courses have been discussed. She also added that courses on Employability/Entrepreneurship/Skill development have been introduced in the VR 22 curriculum.
- Honors and Minors programs continued as per VR 20 regulations.
- Promotion policy, Academic requirement, Attendance requirements, GAP year has been discussed and approved.

Resolution:

- The University nominee have made it clear that the common structure (R23) may be released by APSCHE for adoption.
- They recommended that the organization should adhere to the common framework and regulate VR23 in accordance with the APSCHE recommendations.
- The members have accepted to follow these recommendations and approved.

Item no 2 : Dean Academics presented the following points for Council's approval.

- i. Courses in VR 22 Curriculum
- ii. Programs Structures and Ratification of syllabi for (UG)-VR 22 Curriculum

Resolution:

The Council has approved the courses in VR 22 Curriculum upon verifying the BoS approvals of individual departments.

Item no 2 (b)

- ii. Program Structures and the Syllabi for (UG)-VR 22 Curriculum

Discussion: Deam Academics presented the curriculum of VR 22 UG Programs along with the program structure and academic regulations following choice-based credit system (CBCS). All the courses in the curriculum are framed to impart skill development, employability and promote the spirit of entrepreneurship. The feedback from various stakeholders including employers, students, faculty, parents and alumni for revision of curriculum was reviewed and recommended by BoS. She also presented Skill Development Courses, Project related courses, new courses, value-added courses and add-on courses in order to update the students with latest technologies.

Resolution:

- The Curriculum for VR 22 - (UG) have been approved by the Council.
- They recommended for the change of the number of credits allocated for MOOCs, the total credits must correspond to the duration of the course, i.e., 2 credits for the 12 Weeks course.
- The institute may offer Community Service Projects (CSP) as an alternative to Summer/ Industrial/Research Internships.
- The Council has suggested that when students register themselves for the online courses (SWAYAM and NPTEL), then the institute may also instruct the young faculty having subject background to register for the same course to guide them suitably and and to extend their support still in extendings support to students for successful complete.
- The Council inquired regarding the distribution of marks for Practical Courses (labs) and Supporting documentation to award 10 marks for day to day performance.
- Members have welcomed the suggestion and accepted to implement.

The Council has approved the Academic Calendars of all UG and PG Programs as per the Proposal.

Deam Academics presented the curriculum of VR 22 PG Programs along with the program structure and academic regulations following choice-based credit system (CBCS). All the courses in the curriculum are framed to impart skill development, employability and promote the spirit of entrepreneurship. The feedback from various stakeholders including employers, students, faculty, parents and alumni for revision of curriculum was reviewed and recommended by BoS. She also presented Skill Development Courses, Project related courses, new courses, value-added courses and add-on courses in VR -22 in order to update the students with latest technologies

Resolution:

The Council has approved the Academic regulations, Program structure and Syllabi of M.Tech (VLSI and Embedded Systems) and MCA (VR 22).

Item no 3: Short Semester during Vacation**Discussion:**

The Action Plan to conduct a "Short Semester during Vacation" was proposed by the Dean Academics for the approval of Council. Rector Sir requested the Council to approve the motion after explaining its goals and how it might help the student in achieving academic success.

Resolution:

The Council accepted the proposal and suggested that the institution should submit a representation letter regarding this to the University. They also ensured that this Proposal would be brought to the notice of the University.

Item no 4: Special Supplementary Examination**Discussion:**

The Dean Evaluation made out a request to hold "Special Supplementary Examinations for 4th year students" for council's approval. One of the University nominees has suggested to implement a strong Counselling system, that minimizes the failure rate to a greater extent. In response to that, Rector Sir has emphasised on the Counselling mechanism and the Attendance Tracking System. He continued by saying that the institute's Top-notch academic, Counselling, and Monitoring procedures are in place, despite that, a good number of students miss their placements due to backlogs.

Resolution: The Council approved the Proposal. They also recommended for the submission of representation of the same to the University. They also ensured that all the Proposals would be brought to the notice of the University.

Item no 5: Credit distribution for Project Work and Internship**Discussion:**

The "Credit Distribution of Project Work" proposal was put forward for the approval of Council. The institute suggested a total of 12 credits allocated for the Project which are to be bifurcated into equal portions of 6 credits each for the project and the internship.

Resolution:

The Proposal has received unanimous approval from the Council. They advised that the Credit allocation shall be mentioned as "Project/Internship -12 Credits" on the Statement of Marks , whereas the Project Evaluation and Internship are awarded with 6 credits each.

Item no 6: Ratification of results for the Academic Years 2021-22, as well as the award of Provisional Certificates**Discussion:**

The results of the Academic Year 2021-22, including the award of Provisional Certificates to the qualified students, were presented for approval.


Resolution:

The results and the issue of Provisional Certificates to the qualified students have been approved by the council and also stated that the examinations results are been ratified by separate committee nominated by University can be straightly approved in ACM. Dean Academics was asked to provide the Minutes of Meeting of the Results Ratification Committee as an attachment. The Council further directed

the Organization to send both a printed copy as well as a digital file of the results to the University.

The Council members also advised to maintain the Organization hard-bound and digital copies of the Minutes of the Meeting.

Conclusion: Dr. V. Madhusudhan Rao, Management Representative and Dr. B. Arundhati, Chairman, ACM officially proposed Vote of thanks and formally concluded the Academic Council Meeting.

4. Dean Academics stated that VR 22 Regulations and Program structure was ratified in the 11th Academic Council.

Resolution:

The council has approved the courses and ratified the syllabi for III & IV Year (UG)-VR 22 and MCA VR-22 Curriculum as per the BoS of the respective departments.

Point 3: Academic calendars of all UG & PG Programs

Discussion: Academic calendars UG and PG are placed for approval

The council has approved the academic calendars of all UG and PG Programs as per the proposal.

Point 4: Ratification of the results for the academic years 2022-2023, as well as the awarding of provisional certificates

Discussion:

The results of the academic year 2022-2023, including the awarding of provisional certificates to qualified students, were presented by the Dean Evaluation for approval by the council.

Resolution:

The results and the issue of Provisional Certificates to the qualified students have been approved by the council and also stated that the examinations results are been ratified by separate committee nominated by University can be straightly approved in ACM. Dean Academics was asked to provide the minutes of meeting of

the results ratification committee as attachment. The council further directed the organization to send the University both a printed copy and a digital file of the results.

The council members have advised maintaining hard-bound and digital copies of the meeting minutes.
