Proceedings:

Dr. V. Madhusudhan Rao, Management Representative and Dr. B. Arundhati, Principal cordially welcomed all the members to the Academic Council Meeting.

Institute presented the following points to the JNTUK nominees, industry experts and other members of the Academic Council.

Points Discussed:

Point 1: Approval of Credits for award of B.Tech. Degree –VR 17(Regular students-180 credits out of 189 Credits, Lateral Entry students-132 Credits out of 141 Credits)

Proposed: It is proposed to give exemption for a maximum of **three** courses and to an extent of **9 Credits**. However, student has to clear the Laboratory courses, Internship, Project works for the award of B.Tech degree in VR17 regulation. (UG 4 year program: 180/189 Credits & UG- Lateral Entry program: 132/141 Credits)

Discussion:

1. The Academic Council Members suggested to follow exemption rules proposed in R10 regulation, JNTUK.

Exemption Rule R10 regulation, JNTUK is taken as reference:

"For the award of a degree, candidate has to register for 208 credits and secure 200 credits with compulsory subjects: (compulsory subjects are: all Laboratories and Project work, i.e., the student shall pass all Laboratory examinations and project work]"

2. Members suggested to exempt a maximum of **two courses** to an extent of **6 Credits** by following exemption rules of proposed R10 regulation, JNTUK.

3. Institute assured that all the Regular students have to register for all the courses of 189 credits and Lateral entry students for 141 credits. The exemption rule will be applied if the student has only 2 backlogs by the end of his/her final year. The exemption rule is also applied for the students who have cleared all the courses by the end of final year. The institute will identify the courses with least marks and exclude them in calculating CGPA.

Resolution: The Academic Council members approved the exemption for a maximum of **two courses** and to an extent of **6 Credits** for the award of B.Tech degree for 2017 and 2018 admitted batch students having only 2 backlogs by the end of his/her final year and the exemption rule is also applied to students who have cleared all the courses by the end of final year in calculating the CGPA. (VR17 regulation-UG 4 year program: 183/189 Credits & UG- Lateral Entry program: 135/141 Credits)

Point 2 : To Ratify and approve VR-21 regulation for

VR-21: M.Tech (CSE, ECE, DECS, P&ID, MD & IT), MBA

Discussion: The revised curriculum of VR 21 M. Tech and MBA along with the structure and regulations following choice-based credit system (CBCS) were presented by Dean Academics. All the courses in the curriculum are framed to impart skill development, employability and promote the spirit of entrepreneurship. The curriculum offers soft skill courses for enhancing the employment opportunities. The feedback from various stakeholders including employers, students, faculty, parents and alumni for revision of curriculum was reviewed and recommended by BoS.

Prof. A. Naga Jyothi, Dean Academics presented Skill Development Courses, Project related courses, new courses, value-added courses and add-on courses in order to update the students with latest technologies.

Resolution: Members of ACM have satisfied with the clarifications given by Prof. A. Naga Jyothi, Dean Academics & Prof V. Madhusudhan Rao, Management Representative and considered the ratified regulations.

Point 3: To Ratify UG results for 2017, 2018 and 2019 admitted batch.

Discussion: Institute presented the results of VR17 and VR19 regulations (UG). The overall result analysis for 2017,2018,2019 admitted batches were presented. (Appendix I)


Resolution: The Academic Council members ratified the VR17 and VR19 Regulation examination results of UG(B.Tech)

Point 4: To Ratify PG(M.Tech,MBA, and MCA) results for 2017, 2018 and 2019 admitted batch.


Discussion: Institute presented the results of VR17 and VR19 regulations (PG). The overall result analysis for 2017,2018, 2019 admitted batches presented. (Appendix II)

Resolution: The Academic Council members ratified the VR17 and VR19 Regulation examination results of PG Courses (M. Tech, MBA & MCA).

The 10th Academic Council Meeting was held as per the Schedule with members mentioned through blended mode. The following are the Minutes:

Welcome Address:

- i. Dr.V.Madhusudhan Rao, Management Representative, Mr.N.Srikanth, CEO and Dr.B.Arundati, Principal & Chairperson, cordially welcomed all the members to the Academic Council Meeting (ACM).
- ii. Dr. B. Arundhati, Principal & Chairperson presented various accolades, the highlights of the college and various certificates received by the college.
- iii. The Principal & Chairperson also presented the innovation cell activities, research activities like 'Chunauti-2.O'start-up projects, ATAL ranking, the intake of the institute and quality of the students.
- iv. The Principal & Chairperson reiterated that the enhancement of quality in terms of admissions and placements, was due to teaching learning approaches followed by the institute. The placement record of 2017 admitted students with highest salary packages was also presented.
- v. The Principal & Chairperson concluded the report by stating that the stated achievements of the institute is possible because of the changes brought in curriculum design developments and implementation which moulded the students towards accomplishments of respective goals and placements.
- vi. Dr.V.Madhusudhan Rao highlighted that the number of value added courses and add on courses offered to the students from first year onwards by the institute to meet partially to the Vision of the Institution.

Discussions:

The following items were placed before Academic Council (ACM) for appropriate discussions.

Agenda 1: Confirmation of previous Academic Council Meeting Minutes.

The minutes of 9th Academic Council Meeting held on 18.08.2021 was placed for confirmation. The chair invited comments from the members on the minutes of 9th ACM, with no comments, the members confirmed the minutes.

Agenda 2: Action taken on decision on previous Academic Council Meeting

The Academic Council members approved the exemption for a maximum of **two courses** and to an extent of **6 Credits** for the award of B.Tech degree for 2017 and 2018 admitted batch students in Academic Council meeting held on 18.08.2021.

(VR17 regulation-UG 4 year program: 183/189 Credits & UG- Lateral Entry program: 135/141 Credits). Considering 183 credits for the award of B.Tech Degree in VR-17 Regulations, 886 students of 2017 Admitted batch are eligible for the award of Provision Certificate (PC).

Agenda 3: Revision of Curriculum , Structure and regulations for all programmes of B.Tech, M.Tech, MBA and MCA

- Prof. A. Naga Jyothi, Dean Academics, presented the regulations of VR17, VR19 and VR20 curriculum for the following UG and PG Programs.

VR-17: B.Tech (CE, ME, EEE, ECE, CSE, IT & ECM)

M.Tech (CSE, ECE, DECS, P&ID, MD, IT & SE), MBA, MCA

VR-19: B.Tech (CE, ME, EEE, ECE, CSE, IT & ECM)

M.Tech (CSE, ECE, DECS, P&ID, MD, IT, TE & SE), MBA, MCA

VR-20: B.Tech (CE, ME, EEE, ECE, CSE, IT, ECM, AI & DS)

M.Tech (AI & ML), MCA

- Members of ACM raised certain clarifications on the regulations of VR-17, VR-19 and VR-20 for which Prof. A. Naga Jyothi, Dean Academics has clarified queries and presented the same by providing the minutes of previous Academic Council Meeting held on 21-10-2021 in which said regulations were ratified.
- Members of ACM asked about the implementation process of Honors and Minors programmes for which Prof V. Madhusudhan Rao, Management Representative briefed about the implementation process offered in the institute under VR-20 regulations as per the instructions provided by the APSCHE and the JNTUK University.

Resolution: Members of ACM have satisfied with the clarifications given by Prof. A. Naga Jyothi, Dean Academics & Prof V. Madhusudhan Rao, Management Representative and considered the ratified regulations.

Agenda-4 : The permission to initiate the implementations of new regulations (VR-22) for all UG Programs, MCA and newly proposed M.Tech (VLSI & Embedded Systems) Program.

- Prof. A. Naga Jyothi, Dean Academics proposed the implementations of new regulations (VR-22) for all UG Programs, MCA and newly proposed M.Tech (VLSI & Embedded Systems) Program.
- Dr P.Rajesh, Controller of Examinations requested ACM members to accord permission for changing the mid examination evaluation process of M.Tech, MBA and MCA PG Programs similar to B.Tech Programs.

Resolution: Members of ACM have accorded permission to initiate the implementations of new regulations (VR-22) for all UG Programs, MCA and newly proposed M.Tech (VLSI & Embedded Systems) Program by taking into consideration of APSCHE guidelines and VR20 regulations while designing the proposed VR-22 curriculum. Members of ACM has also stated that the Mid Examination evaluation process of M.Tech, MBA and MCA PG Programs similar to B.Tech Programs can be implemented from next regulations.

Agenda 5: Ratification of

UG results: 2017, 2018, 2019 and 2020 Admitted Batch Students.

PG results: 2017, 2018, 2019 and 2020 Admitted Batch Students.

- The Controller of Examinations (CE) has placed and presented the results of all UG & PG programs which were declared after the seventh Academic Council Meeting held on 18-08-2021 for approval.
- The Controller of Examinations (CE) has presented the eligible 2022 passed out students to take their Provisional Certificates.
- Lengthy discussion taken place in connection with declaration of 2021 passed out students.

Resolution: Members of ACM have ratified all the results presented by the Controller of Examinations with a condition that the JNTUK university authorities' permits for ratification of results of 2021 passed out students. Members of JNTU-GV nominees given clarification towards issue of Original Degrees to 2021 and 2022 passed out students. The members of ACM approved that the Provisional Certificates for 2022 passed out students may be issued by the institution by incorporating both institutional and JNTU-GV university official emblems.
