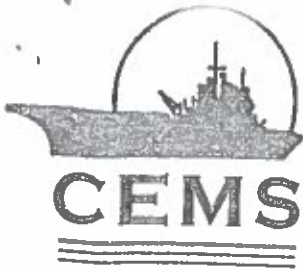

GENERAL AGREEMENT

In order to facilitate industry-institute interaction for technical advancement, to develop academic and industrial relationships and support collaborative research activities, Vignan's Institute of Information Technology, hereinafter addressed as VIIT and Centre of Excellence in Maritime & Shipbuilding, hereinafter addressed as CEMS, agree to establish this Memorandum of Understanding (MOU) as a framework for cooperative programs.

ARTICLE I

Faculty Visits and Training

It is agreed that linkages will be strengthened by visit of faculty from VIIT to CEMS. The purpose of these visits by the faculty is primarily to facilitate the following:

- * Training of the faculty by CEMS on Design, Advanced Manufacturing, Automation and PLM
 - * Training and exposure of faculty with focus on Industry 4.0 Skills
- Arrangements for each such visit will be made by VIIT. Purpose, timing and other details concerning these exchanges and short visits in this regard shall be mutually acceptable to both the institutions. It is agreed that information concerning the purpose and duration of the visit by the faculty, the proposed topics of study, details of the personnel visiting and any further details, as required, will be provided to CEMS by VIIT at least

two weeks prior to the proposed visit. It is agreed that CEMS will conduct Faculty Development Training at mutually agreed cost.

ARTICLE II

Student Training

Further to the above, it is also agreed that CEMS will support and facilitate visits of groups of students from VIIT. The purpose of these visits by the students is as follows:

- * Industrial Internships for IV Year level Students in their 8th Semester to undertake comprehensive internship with hands on skills training on current industry relevant software and hardware.
- * Industrial visit at III year level to undertake mini-projects and pilot studies for full-fledged projects.
- * Industrial visits at II year level to study and understand functioning of an industrial establishment
- * Orientation visits to I year level students to create awareness about various domains in each engineering discipline.
- * Vocational training in Design, Advanced Manufacturing, Automation and PLM to equip students at III year or IV year levels to acquaint themselves with industry 4.0 procedures and operations so as to prepare themselves to face the challenges of the industrial world upon graduation.

As in the case of Article I, arrangements for each such visit will be made by VIIT in the form of formal letters seeking permission as well as the convenience of CEMS to send the student groups. Purpose, timing and other details concerning these exchanges shall be mutually acceptable to both the institutions. It is agreed that information concerning the number of students visiting, duration of the visit, the proposed topics of study and any further details, as required, will be provided to CEMS by VIIT at least two weeks prior to the proposed visit. The above visits will be chargeable by CEMS at mutually agreed cost between CEMS and VIIT. Cost of Raw Material required for projects, where applicable will be borne by the Students.

ARTICLE III

Courses: Seminars, Workshops, Refresher Courses

It is agreed that VIIT will arrange periodic seminars, workshops and refresher courses in collaboration with CEMS. The purpose of these courses is to facilitate and maintain on-going Industry-Institute Interaction as well as to provide a forum for faculty of VIIT as well as

those institutions in the vicinity to discuss on topics of current interest both to VIIT as well as CEMS. Experts from CEMS as well as faculty from VIIT with significant exposure in the topic of interest will coordinate and conduct these courses.

Arrangements for such courses will be made by VIIT in keeping with the convenience of experts from CEMS. Purpose, timing and other details concerning these courses shall be mutually acceptable to both the institutions. It is agreed that information concerning the duration of the visit, the proposed topics of the course and any further details, as required, will be mutually discussed by VIIT with CEMS at least one month prior to the schedule of the course or workshop.

ARTICLE IV Cooperative Research

It is anticipated that significant opportunities, of which a few have been identified, exist for cooperative research between VIIT and CEMS. Such clearly beneficial activities may require specific arrangements. In view of the importance of cooperative research, CEMS will provide necessary support to visiting faculty from VIIT to study research problems at CEMS. The financial implications for utilization of CEMS labs will be on a mutually agreed basis. Such problems will be analysed and solutions suggested by VIIT.

ARTICLE V Competence in Consultancy

It is also anticipated that significant opportunities exist for taking up consultancy works with industries. VIIT has state-of-the-art equipment ideally suited to taking up consultancy work for industries in the area of materials testing, machinability testing, fabrication of complicated parts, vibration analysis and dynamic testing of equipment etc. CEMS also has state of art laboratories with industry 4.0 focus with latest design and testing software and VR capability. CEMS and VIIT can jointly collaborate to provide solutions to industry problems and to develop such consultancy capabilities.

ARTICLE VI Exchange of Scientific Materials

Both the collaborating parties agree to exchange as widely as is practicable such items as scientific publications and journals, university calendars, prospectuses, text books, course outlines and reference materials that may be necessary and of use to either party.

ARTICLE VII
Duration of Memorandum of Understanding

The effective date of this MOU shall be 08.03.2021. The MOU shall extend for a period of 2 (Two) years and may be renewed upon mutual written agreement. The MOU may be modified by mutual written agreement. The MOU may be terminated by either CEMS or by VIIT with notification to the other party six months prior to the effective date of termination.

ARTICLE VIII

AMENDMENTS, RENEWAL, AND TERMINATION

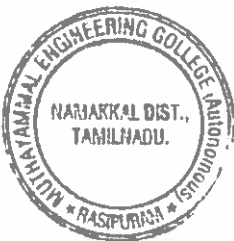
